  - e) Documents in support of previous employments (if employed).
  - f) "No Objection Certificate" if employed in Government/ Quasi Government/ Autonomous Organization(s) if not submitted earlier. Those who have applied on deputation, are requested to bring

- forwarding letter from their employer mentioning that on selection, he/she will be relieved on deputation.
- g) Vigilance Clearance certificate from the employer interview failing which the applicant may not be allowed to appear for interview.
2. Intimation have been sent to the candidates through the registered email. The candidate who does not receive intimation through email, if his/her application number appears in the above list, he/she may also appear in the interview subject to confirmation from RGNAU.
