- 1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. Bidders are bound to accept the orders accordingly.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

4. Generic

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 3 years before the bid opening date. 5. Generic

7. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

8. Service & Support

10. Warranty

11. **OEM**

2. Scope of Work

- (i) Renewal of Firewall at RGNAU premises with 2 years' license and warranty as per specifications.
- (ii) Online and onsite support during the 02 years' licence period as per requirement of University.
- (iii) Technical support for configuration during the contract period.
- (iv) Any defects found in the hardware shall be replaced by the selected agency at no additional cost on the buyer i.e. RGNAU.

3. Payment terms

The payment shall be made within 30 days from the date of successful installation of the licence to the sati sfaction of the University and after receipt of the performance security of 5% in the prescribed format of the University along with other relevant documents required in the contract.

4. Penalty terms

- (i) In case of delay in supply, RGNAU has the right to impose penalty @ rate of 1.5% of monthly contrac t value (to be calculated on per day pro-rata basis).
- (ii) After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 30 days' time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of contract value shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 5% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG.
